What makes ARSI so special is, that in comparison to other players on the market we do not hide behind a brand with a logo - our founders stand for ARSI with their company name ARULSINGAM INVESTMENTS LIMITED. By doing so we wish to create trust and reliability for our investors, our community and our users and at the same time owning up to our responsibility as entrepreneurs as a part of society.

Our business goal is to combine our knowledge and the stability of the real estate sector with our own cryptocurrency and its chances of growth. As experts of both worlds, we wish to create a stable environment for our investors and users of our ARSI coin without losing the immense opportunity that comes with a successful cryptocurrency.

We plan on acquiring a considerable volume of real estate assets to ensure a constant and stable currency flow of ARSI by transferring rental income into our own cryptocurrency and even offer our tenants to pay their monthly rent in ARSI and benefit from the advantages that come with the posession of ARSI token or ARSI related NFTs.

PROJECT ARSI-COMBINING REAL ESTATE & CRYPTO

With project ARSI our founders combine the extraordinary opportunities that come with the creation of a new cryptocurrency, that is supported by stable real estate investments with the goal that its continuous success will also benefit people in need through ARSI Charity.

Project ARSI plans to build a considerable real estate portfolio with the focus on large metropolitan areas in the UK and Europe, starting with investments in the German real estate market. To identify suitable assets to add to our portfolio we can rely on our experience and a strong international network of real estate professionals, that will identify, acquire, develop and manage our real estate portfolio. Purchasing and investing in real estate projects requires significant investments from our side. As a company with a strong background in crypto, we do not want to rely on

financial institutions to provide the required funding — even if it means that we reduce the return on equity in the purchase process. Thanks to our investors and our own stable equity base, we can purchase real estate assets without relying on bank loans, which also means that we are not depending on low interest rates like other potential real estate investors.

This considerable amount of real estate assets is creating a solid base to support our companies' own ARSI coin, a smart contract developed cryptocurrency deployed on Binance Smart Chain. In addition to the real estate assets serving as a stable provider for ARSI demand, the portfolio will also provide a constant source of transactions in ARSI itself.

Our tenants, as a first use case for ARSI, will have the opportunity or option to participate by paying their rent in ARSI, therefore benefitting from a basic discount and depending by the amount of ARSI that they have an additional discount, compared to their rent in a "regular" currency which makes us one of the first large scale asset managers and landlords to accept cryptocurrency as a payment method.

Our own asset management will in any case transfer parts of the monthly rental income into ARSI therefore further stabilizing our coin. In addition to the rental incomes, we as a company will ensure to execute payments as often as possible in ARSI within our company structure or with our partners and employees. We are sure that with this combination of reliable non-digital assets and an innovative cryptocurrency, we can create a stable, lucrative and reliable investment environment for our community.

The more investors we can convince to join us and the more assets we can acquire, the more the value of ARSI will increase, creating additional benefits for our community of ARSI holders, who will get the benefits based on our own reward ranking system.

WEALSO WANT TO SHARE



ARSI CHARITY - MANY ISSUES - ONE SOLUTION

We strongly belief that our success should not exclusively benefit our community but to society. For this reason, we are creating ARSI Charity, an organisation within ARULSINGAM INVESTMENTS LIMITED that will own a significant amount of ARSI, benefitting on its positive increase in value over time and ultimately uses the value and funds created to improve several issues in societies worldwide.

There is no specific group we are planning to support, ARSI-Charity will support anyone who is in need regardless of his location, gender, or ethnicity.

10% of the total ARSI supply will be stored in a separate hardware wallet, named ARSI-Charity. It will be only used for donation purposes and nothing else.

We will use our community as a sounding board to discuss further details regarding ARSI-Charity and share of information to improve our plans.

We will not sell the ARSI, stored in the charity wallet, all at once or in a short period, to avoid a massive impact on the market.

To be able to manage everything, we are obliged to act transparently and in the interests of the general wellbeing of investors and clients and to manage the "charity wallet" through one of our employees.

Every transaction with ARSI is listed on the blockchain. You can follow all transactions on bscscan.com

The address of the "charity wallet" will be announced to the community and listed on the website. Every transaction from this wallet can be tracked by anyone. Thus, we guarantee you that the ARSI-CHARITY project will also run under your supervision!

The private keys of ARSI-Charity-Wallet" will be stored offline to be protected against theft and any other unwanted external access.

Although the charities to be funded will be discussed in our community we want to line-out some issues that we will focus on to begin with:

Worldwide overpopulation — the world's population is consistently increasing especially in the poorest of countries in the world. The lack of general education, professional perspectives and even sexual education are one of many issues that we need to approach to fight overpopulation. ARSI Charity will use the funds generated by Project ARSI to fund existing charities that already help to improve the situation in countries in need.

Lack of clean water — Did you know that in some places of the world people have to walk up to 12 miles to get enough water to survive the day? Millions of people have no access to clean drinking water or a proper hygiene. The increasing effects of climate change will only amplify the problem. Providing access to clean water, creating the necessary infrastructure or even investing in seawater desalination in combination with solar energy might be worth exploring to make a difference.

ARSI Charity is eager to provide funding for suitable projects to ensure that more people will have a safe access to a sustainable water supply.




PROJECT ARSI-HOW WE WORK?



CREATING A STABLE BASE FOR ARSI

ARSI will be directly linked with our companies' real estate assets, we hereby will create a system that provides for itself. As a start we will focus on using our real estate business and our NFT collection to establish and strengthen ARSI as a utility token. As we grow, we will decide upon further use-cases for our currency. Our real estate portfolio will constantly create a rental income in FIAT currencies that will be exchanged into ARSI by our team and therefore creating a steady demand in ARSI.



We want ARSI to be a beneficial utility token for its community. Besides the possibility to execute rent payments and the charity pool we want to create other opportunities to benefit from our project by owning ARSI. The following use cases are first approaches on how to make the ARSI project a pleasant and beneficial project for its community.




INCENTIVIZING THE COMMUNITY

We want to give continuous loyalty benefits to the users who are using the ARSI token. First and foremost, this will apply to tenants with our own real estate portfolio, but we plan to extend the benefits to all ARSI holders with the growth of our real estate portfolio and given the nature of the real estate asset. The possibilities are reaching from a monthly discount on an ARSI users rent in one of our apartments to a discount for a holiday home or short-term rental office or apartment in one of Europe's major cities. We will inform the community on a regular basis about new benefit opportunities and what rank is necessary to benefit from them. We hereby plan to form a loyal and motivated community for ARSI that shares our passion for real estate assets and crypto.

To give an example on the ranking system for our own tenants we want to show a case scenario that we intend to apply within our rental apartments buildings. Let's assume that users get a 4% default discount on their rent if they pay with ARSI compared to fiat. Each consecutive rank will add 2% to these 4%.

The token holder has spent ARSI equal to paying 30,000 USD worth of rent in FIAT.

Rewards: +6% discount on all future rent payments, total discount with the default one becomes 10%.

The token holder has spent ARSI equal to paying 20,000 USD worth of rent in FIAT.

Rewards: +4% discount on all future rent payments, total discount with the default one becomes 8%

The token holder has spent ARSI equal to paying 10,000 USD worth of rent in FIAT.

Rewards: 2% discount on all future rent payments, total discount with the default one becomes 6%.

We are planning to implement several ranking systems for our community. As of now besides the above mentioned ranking for tenants, there will be a ranking systems for ARSI holders and NFT holders giving them unique benefits such as access to airdrop and reward events or exclusive discounts within our real estate portfolio depending on their rank. Your rank will in general be defined depending on how many ARSI the community member is holding in its ARSI dashboard.

MAKING ARSI EASY-TO-USE WITH THE ARSI DASHBOARD

We wish to create an easy-to-use opportunity for our community and ARSI users to interact with us and our token. Therefore, we intend to create the ARSI dashboard.

The first feature we intend to launch is the possibility to buy our token through simply registering on our dashboard and completing the underlying KYC process. In the early sales phase this will be the main purpose of the dashboard, the final layout might change and additional functionalities will be implemented.

ARSI DASHBOARD



The dashboard will have multiple functionalities, ranging from but not limited to:

ACTIVITY	DESCRIPTION
Purchasing Token	Buying ARSI will be the first functionality that we intend to establish. We are currently in the selection of a suitable marketplace to connect with our purchasing function.
E-Wallet Connection	Connecting your wallet e.g. Meta Mask will be made possible which will allow the users to easily trade cryptocurrencies for ARSI.
History of transactions	In their dashboard, every user will have the full information about their past transactions, rent

payments and current balance in ARSI etc.

NFT collection

Our own ARSI NFT collection — if you own one — shall be visible in the dashboard.

(Rent) Payment facilitation

Token holders will have the option to execute rent payments in the ARSI token directly through the platform. This adds a real sense of use-case environment for the token and creates additional value through better usability of the process, translating into higher incentive for the token holders and connecting the tenants of the A&S Investments Real Estate portfolio directly and easily with ARSI.

Hierarchy tracking

All ARSI and NFT holders are entitled to discounts for example as tenants within our real estate portfolio. Depending on how much FIAT value was spent in ARSI or if you own an ARSI NFT this rank will increase and benefits/discount will grow. Discount can be accounted on rental payments or other opportunities with our real estate portfolio (holiday homes, office spaces etc.), depending on the completed real estate deals.

Knowledge resources / news/ Blog

We want to give users access to a wide variety of knowledge and resources related to the real estate markets, the buildings they are living in and the charity initiatives, raising awareness of different topics you are targeting with the charity campaigns and others.

The dashboard could thus be used for easy communication to your token holders while also facilitating the main use case of the token (rent payments).

Voting

As mentioned in the Whitepaper, transparency and an open exchange with our community is important. We want to establish our dashboard as a voting tool for our community to receive the input of our ARSI holders on our project. This way the community will be empowered to participate as a sounding board for Project ARSI and ARSI charity.

HOW TO BUY ARSI?

As for the moment we intend to make it as easy as possible to participate in our venture. To buy ARSI with cryptocurrencies or FIAT, you just have to go to our website:

www.arsi-crypto.com and follow the instructions to set up your personal ARSI dashboard.

HOW TO WITHDRAW ARSI INTO FIAT-CURRENCIES?

To sell ARSI, you simply must go to one of the exchange websites and swap ARSI to BNB.

Transfer the **BNB** to **Binance.com** and exchange it to any FIAT-Currency and withdraw it to your bank account.

HOW DO WE USE THE "REBUY AND BURN" PROCEDURE AT ARSI?

To increase the stability and market value of ARSI, the developers of ARSI are considering to burn up to 20% of the total ARSI supply on the long run. We are planning to buy back ARSI from the open market at the current market price with the purpose of burning the bought ARSI to stabilize the market value.

The exact burn day - the day when a fraction of the ARSI tokens will be burned - will not be announced in advance.

An increase in the value of the coin can be expected from the action just mentioned.



SECURITY * * * * *

The security of our project is of the highest value and crucial for a stable operation. Our token is created using the latest version of the audited contract from OpenZeppelin. This is of the highest standards on the market and therefore state-of-the-art. We chose this technology to ensure precautionary security measures for our marketplaces and avoid any risk of compromising the security of our system.

The developer will transfer nearly 100% of the total supply to a hardware wallet, where it's stored at the highest security standards, until fundraising and liquidity providing has been finalized from our side.

All wallets, including the charity wallet, will be stored in a highly secured hardware wallet, where it's safe from unwanted external access.


SIMPLE BUT USEFUL!

In terms of Marketing we intend to use the full possibilities of the modern marketing playbook. Below you will find some of the most important marketing activities that we are planning to implement with our marketing agency.

CONTENT AND PR MANAGEMENT

To increase the awareness for our endeavor, we are looking to advertise our project through high quality content marketing on our own channels and official press releases, that will regularly report our achievements of key milestones in fundraising, real estate deals or any other relevant ARSI related news.

COMMUNITY BUILDING AND MAINTAINING

We are already an international community from England, Germany, Sri Lanka, Denmark, India, and the Netherlands, growing in members from different countries every day, but building a community on Social Media channels such as Telegram and interacting with our community across all channels to promote high engagement is arguably our most important marketing goal, especially in the early stage of our project. Various of the below mentioned marketing efforts will help to increase and incentivize our community.




NFT

In addition to our overall Marketing strategy, we plan to create a portfolio of ARSI related Non-Fungible-Tokens (NFTs) to increase the popularity an awareness of ARSI in the market. Our companies own tech-lion will be the inspiration for a limited portfolio of NFTs that will be offered on the market and to our investors to, in a best-case scenario, provide additional funding and liquidity to our project, besides the obvious marketing effect. The NFTs are always based on four base pictures that become a set of 25 NFTs per picture and build up to seasons that end in a collection of 2.500 NFTs. In total only four collections will be available, making it a limited portfolio of 10.000 NFTs.







Liquidity pools






